FINANCIAL REPORT

EXECUTIVE DIRECTOR'S REPORT

Mr. Holiway introduced Kathy Hicks, LIHEAP Coordinator. Ms. Hicks made the request to transfer funds that both Anderson County and Campbell County had left between other counties that still had wait lists. Ms. Hicks reported that approximately \$50,000 was still left and about 350 applications were still waiting.

MOTION: TO ACCEPT THE REQUEST TO TRANSFER FUNDS IN THE LIHEAP PROGRAM FROM ANDERSON AND CAMPBELL COUNTIES TO COUNTIES THAT STILL HAD WAIT LISTS AS PRESENTED. THE MOTION PASSED.

Mr. Holiway introduced Ms. Jane Keck, the new payroll manager for ETHRA. Ms. Keck stated she was glad to be a part of the ETHRA team.

Mr. Holiway then asked Ms. Jessica Stewart and Ms. Katie Somoza to give an update on the Community Corrections Program and RFGP.

Ms. Stewart gave an update on the status of ETHRA's application and that the award date notification had been moved out again and we had not been notified of any negotiations either. Some questions and further discussion was made by the board and both Ms. Stewart and Ms. Somoza answered the questions to the satisfaction of the board.

Mr. Holiway notified the board of the newest grant award from the Y12 Gives Foundation of \$10000.00. He noted that the award would benefit the At-Risk Supper Program and Home Care Child Food Program.

Mr. Holiway then asked Veronica Stephens, Program Manager of Child Care Homes, to present about the current status of the child care homes and new certifications implemented by the state.

Mr. Holiway reminded the board that it was time once again, to sign and submit the annual Conflict of Interest forms. He asked that each board member sign and submit the forms as quickly as possible.

Mr. Holiway reminded the board of the upcoming annual Tennessee Human Resource Agencies Training and Conference, scheduled for August 16-19, 2022, at the Park Vista Hotel, Gatlinburg, Tennessee. He invited all who might want to, to attend.
