FINANCIAL REPORT

ETHRA Treasurer, Glenn Jacobs, gave the financial report for the period ending November FY 2023. Mayor Jacobs asked if there were any questions regarding the financial report. There were no questions.

EXECUTIVE DIRECTOR'S REPORT

Mr. Holiway stated that a resolution was requested by Aaron Bradley and reported by Mr. Holiway for Resolution requesting that East Tennessee Legislation create a new group home licensing category in Tennessee, update adult protective services laws and work to create a dedicated TBI call center to support banks and credit unions to investigate and stop financial exploitation of older Tennesseans.

Mr. Holiway stated that Mayor Mark Potts requested to make an announcement - Mayor Mark Potts made a motion for proceeding with the feasibility study to for current space needs, future growth needs of ETHRA and the proposed purchasing of a building and that a cap of \$10k was to be the budget to hire an architect to conduct the feasibility study.

MOTION: TO ACCEPT THE MOTION OF CONDUCTING A FEASIBILITY STUDY WITH THE HIRING OF AN ARCHITECT WITH A BUDGET OF UP TO \$10K. MOTION WAS MADE BY MARK POTTS AND SECONDED BY BILL BRITTAIN. THE MOTION PASSED.

Mr. Holiway then reported on the current square footage ETHRA currently has; anticipated needs, potential new programs being added and the fact that all program managers needed to be housed in the corporate ETHRA office. Mr. Holiway noted that currently, ETHRA has had mechanical, HVAC and IT issues with the leasing company and seems to be an ongoing issue. Mr. Holiway gave an update on current leased storage building located on Middlebrook Pike as the need for additional storage. Mr. Holiway gave an updated timeline of the

current lease which is up February, 2024 with a requirement of notice by May, 2023.

Mr. Holiway stated that supporting documents that was requested by the steering committee would be sent via e-mail with recommendations, assessment of needs, and other information for committee to begin and proceed with a Proposal in April or May, 2023.
