- 4. Description of the challenge the sponsor is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted.

The amount of time involved and the increased expense of travel will pose a challenge. The sponsor will be able to use the time and expense for other aspects of the Summer Food Program. ETHRA foresees an improvement in services by using the time saved from doing additional first week visits to provide more training for potential new sites and will also be able to conduct additional monitoring visits to sites that may need some additional assistance. The expense saved on travel can be used towards promotion of the program in general in the large area that ETHRA serves during the summer.

5. Specific Program requirements to be waived (include statutory and regulatory citations). [Section 12(I)(2)(A)(i) of the NSLA]

ETHRA is requesting to waive program regulations at 7 CFR 225.15(d)(2) regarding first week visits. Regulation will require all sponsored sites to be visited during their first week of operation.

ETHRA is requesting a waiver for the first week site visit requirement. ETHRA is seeking a waiver to complete site revisits for returning sites that operated successfully during the previous summer without serious deficiencies. ETHRA has successfully operated the Summer Food Program for over 30 years and is in good standing.

6. Detailed description of alternative procedures and anticipated impact on Program operations, including technology, state systems and monitoring:

ETHRA does not anticipate any impact on the Program operations, including technology, state systems and monitoring.
